

**Public Hearing
Motor Freight Terminal Conditional Use Hearing #37
October 6, 2009**

The North Middleton Township Supervisors held a continued public hearing on October 6, 2009 at the Township Municipal Building, 2051 Spring Road, Carlisle PA. Chairman Robert Reisinger called the hearing to order at 6:35pm. Board members present Vice Chairman Harry Kelso, Supervisor Robert Shearer, Supervisor Richard Bucher, Solicitor Mark Allshouse, and Recording Secretary Dana A. Billet

The Pledge of Allegiance to the American Flag opened the meeting.

Supervisor Reisinger stated that there is a sign in sheet and everyone should sign in if they haven't already done so.

Supervisor Reisinger stated that this is a continuation of a Third Pine Floor Partners Conditional Use application. The purpose of tonight's meeting is for the Board to discuss that application based on the testimony previously received.

Supervisor Reisinger stated that there are only four board members here, but North Middleton Township does have a five member board. In January 2009, Supervisor Hurley resigned and Mr. Jim Hare was appointed to replace him. All parties agreed that the decision would be made by the four board members who have been here since the beginning of the hearings. Supervisor Reisinger stated that if the Board votes and it is a 2 – 2 vote that is not a majority vote and a majority vote is needed to approve a motion.

Supervisor Reisinger ask if there were any additional comments before they proceed. The Board had none.

Supervisor Reisinger stated that at the last meeting the Board had the opportunity to ask questions of both sides. The Board then ask for more time to review previous transcripts. Supervisor Reisinger ask if the Board had any additional questions. The Board had none.

Supervisor Reisinger ask if any of the Board members were willing to make a motion to approve the plan as submitted without any conditions. A motion was not made.

Supervisor Reisinger made a motion to approve the plan subject to conditions to be determined after further discussion and the second vote of this Board approving those conditions. Supervisor Kelso seconded the motion. Supervisor Reisinger ask if there were any questions on the motion or any discussion on the motion. The Board had none. Supervisor Reisinger stated that with no further questions they would call for the vote. Supervisor Reisinger stated it would be a roll call vote. Supervisor Bucher voted no, Supervisor Shearer voted no, Supervisor Kelso voted yes and Supervisor Reisinger voted yes. The motion did not carry.

Supervisor Reisinger stated since the motion did not carry to approve the plan with conditions the application is denied. In accordance with the MPC the Board will prepare written findings to deliver them to the applicant by October 26th.

Supervisor Reisinger ask if the Board had anything else. The Board had nothing.

A full transcript of the hearing can be found at the Municipal Building.

Adjournment

Supervisor Reisinger made a motion that the hearings are closed and the meeting be adjourned. Supervisor Shearer moved the motion and Supervisor Bucher seconded.

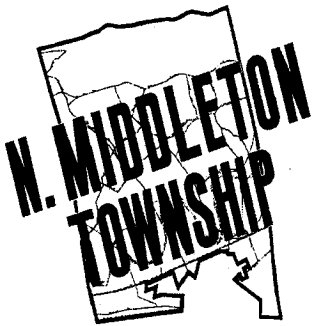
