ORDINANCE NO. 2010-01

AN ORDINANCE OF THE TOWNSHIP OF NORTH MIDDLETON AMENDING, CHANGING AND MODIFYING ORDINANCE 92-3 WITH REGARD TO THE CODE OF ORDINANCES OF NORTH MIDDLETON TOWNSHIP, 1979, CHAPTER XV, PART 2, SECTION 13 – LEFT AND/OR RIGHT TURNS PROHIBITED AT CERTAIN INTERSECTIONS; PART 2, SECTION 15 – STOP INTERSECTIONS ESTABLISHING AND CREATING CERTAIN STOP INTERSECTIONS AND PROHIBITING LEFT HAND TURN, ALL IN NORTH MIDDLETON TOWNSHIP

WHEREAS, the Board of Supervisors of North Middleton Township has in the past enacted Ordinances regulating traffic and parking, specifically, establishing and creating speed limits, stop intersections and no left turns; and

WHEREAS, the Board of Supervisors of North Middleton Township is desirous from time to time of establishing, creating, removing or deleting additional stop intersections and no left turns in North Middleton Township as traffic conditions and patterns change and grow within North Middleton Township; and

WHEREAS, this Ordinance and the objections leading to its enactment are authorized by The Second Class Township Code, Act of May 1, 1933, P.L. 103; Act of July 10, 1947, P.S. 1481 (53 P.S. § 65101, et seq.) as amended; and by the Vehicle Code, Act of June 17, 1976, P.L. 162, No. 81 (75 Pa. C.S.A. 101, et seq.) as amended; it is therefore enacted and ordained by the Board of Supervisors of North Middleton Township, Cumberland County, Pennsylvania as follows:

Section 1. Amendment.

The restriction of making a left hand turn while traveling East on Crain Drive onto Route 34 Spring Road is hereby removed and vacated. An operator of a vehicle shall no longer be prohibited from making a left turn when traveling East on Crain Drive onto Spring Road.

Section 2. Continuation.

The provisions of this Ordinance, so far as they are the same of Ordinance No. 92-3 are intended in continuation with the exception of the attached amendment. All other provision of Ordinance No. 92-3 shall remain in full force and effect. Provisions of this Ordinance shall not affect any act done or liability incurred, nor shall they affect any

suit or prosecution pending or to be instituted to enforce any right or penalty or to punish any offense under the authority of any Ordinance repealed by this Ordinance.

Section 3. Effective Date.

This Ordinance shall become effective in accordance with law.

Section 4. Severability.


In the event that any provisions, section, sentence, clause or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Ordinance or other Ordinances affected by this Ordinance, it being the intent of North Middleton Township that such remainder shall be and shall remain in full force and effect.

Section 5. Relationship to Other Ordinances.

All other Ordinances, parts of Ordinances or parts of Resolutions inconsistent herewith shall be and the same expressly repealed.






